

A) Scope of work of Stator Rewinding and Core Restaggering:

Scope of work for Item No's:

02. ELHTM02GN630 -HT MOTORS (>500-1000KW) Matl Supply,

Service Part:

06. ELHTM02BD804 -HT MOTORS (>500-1000KW)-Rewdg,

08. ELHTM15BD101 -HT MOTORS (STATOR) CORE RESTAGGERING

- 1) The scope of work envisages rewinding of stator of HT motor of TTPS at agency's works.
- 2) The existing winding of stator will be stripped out .The stator core will be cleaned properly and hot spot (Full Flux) test will be carried out in presence of NTPC representative at agency's works (Ref: First stage inspection clause no a-1). The agency will submit the test report to EIC for checking, if results are found satisfactory, then clearance will be given. Otherwise NTPC representative will witness the test.
- 3) Fabricating a set of new stator coils with new double glass enameled covered copper conductor machine wound suitable for class-F insulation (Bare conductor as per IS 6160/71 and enamel covering as per IS 3855 Pt #IV-1992). Conductor size should be as per original.
- 4) During hot spot checking, if hot spot (Full Flux) will be there on the core, then core re-staggering to be carried out at extra cost and time. After rectification of core final hot spot (Full Flux) will be carried out by the agency & will be witness by the NTPC representative.
- 5) All insulated winding should be non hygroscopic, oil resistant and the material resistant to flame propagation. All coils should be varnished and suitable processed to effectively seal and prevent deterioration from adverse environmental condition at site during operation period.
- 6) Stator winding to be carried out with fully tested coils.(Ref First Stage inspection clause no a-2)
- 7) Slot wedges should be made up resin bonded glass fiber as per IS 9299.
- 8) The overhang portion of the coils should be insulated with GMP and Glass fiber tape using epoxy as binding material and the slot portion of the coil with SEMICATHERM as binding materials as per IS 6160 /71.
- 9) The coils should be placed in the slots with epoxy glass textolite as bottom liners, inter phase separators, top liners and wedges.
- 10) Complete winding should be adequately supported, braced and blocked to provide sufficient rigidity during all normal condition of services.
- 11) Inspection & Testing: The Agency will intimate the Engineer-in-charge for inspection .The following tests is to be conducted during inspection.
- AA. First stage inspection.

a1)-Stator core testing:- The bare stator core shall be tested with full flux loop test and checked for hot spots with contact type thermometer. Hot spot not to exceed average temperature of core by 10 °C after one hour with full flux (stator full load current) applied to stator core. If hot spot will be found, the core re-staggering to be carried out at an extra cost and time.

- a2)-Testing of coils:-Following test shall be conducted on all the stator coils in presence of NTPC representative during first stage of inspection. The agency will inform 15 days in advance for inspection. If due to some unavoidable circumstances, inspection would not be executed by NTPC in time, then the agency will carry out all the tests and send these test results to engineer-in-charge for information and clearance.
- i. Inter turn insulation checking of all stator coils by Surge comparison test at 10 KV A.C.
- ii. HV test of coils at 18 KV AC for 1 min before placing in side the core.
- iii. Loss angle (tan delta) measurement of all the coils shall be taken before winding in steps of 20,40,60,80 and 100% of the rated voltage.
- AB. Final stage of inspection:-
- i. The complete rewound stator shall be flash tested at 14.2 KV AC for one min and insulation resistance of each phase shall be recorded before and after HV test.
- ii. Stator winding DC resistance measurement to be taken.
- iii. Measurement of IR & PI with motorized megger.
- iv. Surge comparison test at 14.2 KV A.C on complete stator winding.
- v. Loss angle (tan delta) measurement of complete stator winding at the rated voltage in at least 5 steps.
- AC. The agency will submit a detail test reports with the rewound stator.
- AD. Both first & final stage inspections are to be witnessed by NTPC representative.

- 1) The end rings and rotor bars will be removed by brazing at agency's workshop
- 2) During removal of old bars agency should take care not to damage the rotor accessories such as core, and cooling fans etc.
- 3) Thorough cleaning of rotor and slots
- 4) Checking of rotor stamping, insulation and rectification.
- 5) The party has to make the new rotor bars by identical material or improved design bars without affecting the rotor electrical properties as well as mechanical properties.
- 6) The party will submit new drawing of the bars.
- 7) Placing newly manufactured rotor copper bars
- 8) Brazing of rotor bars and end rings
- 9) Checking of any looseness and rectification of the same
- 10) The complete rotor dynamic balancing to be done by the party in presence of NTPC/TTPS authorized representative

- 1) The rotor shaft run out to be checked immediately after receipt of the rotor and if any damage or run out is found, the same to be informed to EIC for necessary clearance for carrying out re shafting job.
- 2)If shaft dimensions and run out is within the permissible limits, then Reshafting job of rotor will not be carried out and these items will be kept as optional (Later PO amended for deletion of these items).
- 3) The rotor shaft will be dismantled by hydraulic jack at the agency's workshop
- 4) During removal of old shaft agency should take care not to damage the rotor accessories such as core, rotor bars, end rings and cooling fans etc.
- 5) The party has to make the new shaft by identical material (EN-8) of old shaft.
- 6) The party will make new shaft dimension wise exactly identical to old shaft
- 7) The shaft machining to be done properly. The finishing of journal area of the shaft should be suitable for Babbitt journal bearing) i.e NS grade with surface finish of $0.4 \mu m$) and other place single triangle method

- 9) After removal of the shaft agency will inform NTPC/TTPS for inspection
- 10) The inspection of new shaft must be done in presence of representative of NTPC/TTPS
- 11) The shaft dynamic balancing to be done by the party in presence of NTPC/TTPS authorized representative.
- 12) The rotor core, coupling, internal cooling fans & external fan hub are to be fitted with the shaft before balancing
- 13) Old shaft will be retained by the agency & to be kept till final stage inspection of the rotor
- 14) 1st stage inspection will be done after removal of old shaft and final inspection will be done during balancing (UI & DP, final dimension check and balancing)
- 15) Details dimension measurements balancing report, test certificate of materials from approved testing agency etc are to be submitted by the agency to NTPC representative.
- 16) Inspection: 1st stage inspection after removal of shaft and Final stage inspection during balancing. This inspection should be matched with 1st and final stage inspection of the rewinding job of stator.

- 4. Guarantee:-12 months from the date of commissioning or 18 months from the date of delivery whichever is earlier.

Separate invoices for material part and service part to be raised by the agency, even though material is integral part of the motor. 10. All the materials like winding coils, Rotor bars, rotor shaft and insulating materials etc to be used for completing the rewinding job of stator and rotor. There will not be any supply of materials by NTPC; for the taxation purposes material and service parts have been separated. These materials are integral part of the motor and utilized for executing the rewinding job.

FOR ITEM 10 :- Separate Material PO No.4000199075 created to facilitate the supply payment of material supply portion.

- 11. a) 90% payment alongwith 100% taxes against submission of GSTIN invoice shall be paid through DD. the DD shall be hhanded over on certification of EIC regarding completion of the job in all respect including submission of Inspection & Test Report.

- 14. If any extra material is required for completing the job like welding works, machining works, replacement of terminal bushings, replacement of space heaters, Painting, Labeling and RTDs are to be provided without any extra cost and time.
- 15. The item (C) of SOW, The Rotor reshafting (Items 10.30 and 20.50) job is optional item and will be carried out if any damage or run out is found.

ESI ACT

- 1) The scope of work envisages rewinding of stator of HT motor of TTPS at agency's works.
- 2) The existing winding of stator will be stripped out .The stator core will be cleaned properly and hot spot (Full Flux) test will be carried out in presence of NTPC representative at agency's works (Ref: First stage inspection clause no a-1).The agency will submit the test report to EIC for checking, if results are found satisfactory, then clearance will be given .Otherwise NTPC representative will witness the test.
